CBD6S 200 W and 300 W (SMPS)

The DESKLINE® control box family CBD6S (SMPS) is an optimum choice for a wide range of desk applications. The CBD6S is perfect if you need a small and compact control box that requires a minimum of space when mounted. The CBD6S lifts the line of intelligent DESKLINE control boxes to a new level. While keeping the advantages from earlier generations it adds so much more. It is the most compact and lightweight control box in the DESKLINE series. It keeps the same width as DESKLINE columns with motor housings ensuring that it fits into a topframe, and it is only 38 mm high. From a design perspective, the control box is more intuitive. It has plugs for connection of the legs in each end of the box and it is equipped with cable grooves at the bottom making it easy to lead and hide motor cables from one side of the desk to the other. Furthermore, the plugs are white so they are easily recognised under the desk.

The CBD6S is available in 2 main versions, a 2-channel version (200 W) and a 2, 3 or 4-channel version with more effect (300 W). The CBD6S 300 W is a universal control box meaning that it works worldwide, just add the required mains cable. The control boxes CBD6S are compatible with the entire DESKLINE product programme of columns (DL), built-in actuators (DB) and desk panels as standard. The control box ensures smooth drive of the desk and soft start and stop of the connected columns.

Further features are autodetection of the type and number of DL/DB, making the CBD6S very intuitive to use in a desk design.

From an environmental point of view, the CBD6S is a good choice as the CBD6S has extremely low power consumption in standby mode, only 0.1 W and the CBD6S control box is PVC-Free™, which is state-of-the-art.



CBD6S 200 W features:

- The CBD6S can be connected to 1 or 2 DESKLINE® actuators / columns
- Mains voltage 230 VAC, 50 Hz, or 120 VAC, 60 Hz
- Ultra-compact; length 210 mm length
- Lightweight control box; weight only approx. 400 g

CBD6S 300 W features:

- The CBD6S can be connected to 1, 2, 3 or 4 DESKLINE® actuators / columns
- Mains voltage 100-240 VAC, 50-60 Hz (universal)
- Ultra-compact; length 265 mm length
- Lightweight control box; weight only approx. 500 g

- Cable grooves at the bottom to optimise cable management
- White plugs for easy recognition when mounting/dismounting
- PVC-Free™ as standard
- Low standby power consumption – only 0.1 W. This is what we call ZERO™
- Exchangeable standard mains cable

Options:

- Anti-Collision™. A system with Anti-Collision can limit the material damage on a desk if a collision with a solid object should occur (only for 3-stage columns)
- Compatible with the battery box BA001 (CBD6S with SW version 1.37 and later)
- All CBD6S 200 W can charge the battery box BA001
- All CBD6S 300 W delivered from factory with SW version 1.57 and later can charge the battery box BA001
- Desk Sensor™ 1 (CBD6S with SW version 1.63 and later)
- CBD6S with SW version 1.37 and later is as standard equipped with multi-parallel software (only CBD6S with SW version 1.46 or later works in multi-parallel systems with DPG).
All CBD6S used in a multi-parallel system must always contain the same software version.
- Compatible with Safety Limit Switch CBDSLS.

Usage:

- Duty cycle max. 10 % \approx 2 minutes continuous use at full load, followed by 18 minutes pause
 Always observe the duty cycle stated on the column product label as this may be lower
- The control box is compatible with all DESKLINE® columns, built-in actuators and DESKLINE controls
- Please note the LA23, LA31, DL1A, DL2 and DL61 1200 N without PIEZO™ and BL1* require a special configuration (use the CBD6S configurator)





1 and 2	Sockets for one or two DL/DB


CBD6S 300 W
